The meet is being hosted by the Southern California Imperial Owners (SCIOI). Santa Maria is known for its long history in Aviation so you don't want to miss our visit to the wonderful **Museum of Flight** that is located near our host hotel. We will have the \$50 name badge drawing, at the Banquet, again this year! This year, each registration will include ONE voting ballot for Saturday's Show (with or without an Imperial in the Show).

Breakfast: A Continental breakfast will be served daily in the SCIOI Hospitality Room or you may purchase one in the hotel dining room.

Thursday, May 15, 2014, 2:00 pm, we drive to the **Santa Maria Museum of Flight** for a photo op on the airport tarmac, in front of the hanger, a docent led tour, followed by their special hamburger supper.

The current Santa Maria Public Airport – originally named Army Air Field (on which the museum is located) was originally built to train bomber pilots during World War II. In 1945 the Army Air Field based the first jet fighter squadron in the Army Air Force, flying the Bell T-59 aircraft (pictured above). As the war wound down, this unit transferred to March Air Base in Riverside CA. In 1964, the Army Air Field was renamed Santa Maria Public Airport. (www.smmof.org)

In 1983 the importance of establishing an aeronautical and exhibits museum became apparent and within one year the museum was built in the airport's gift shop. They outgrew that and moved into an used metal hanger. Walt Disney built a hangar at the airport as a prop for the movie "Rocketeer". After the movie was filmed, the museum acquired the new hangar. The museum is now housed in these two hangers. (When the near-by Lompoc aerospace museum closed, all their assets were transferred to the Museum.)

Friday, May 16, 2014, 10:00 am, we head out to the **Guadalupe Dunes** (the largest remaining dune system south of San Francisco) and then meander over to Casmalia for the "Worlds Best Barbeque" at the **The HITCHING POST**. This is Santa Barbara County's landmark number 37. The building was originally the Casmalia Hotel and thrived in the town of Casmalia during the turn of the century; which saw the railroad and oil booms of the era. The hotel and saloon was sold in 1920 to a couple that provided their guests with home-cooked Italian meals. Their son Mario and his partners converted the former hotel to a steakhouse and reopened it October 1946 as "The Hitching Post". In 1952, the business was purchased by the Ostini brothers, Frank and

Victor. Frank and his wife, Natalie, operated the restaurant until 1977. After operating it for two years, sons Bill and Frank, Jr., purchased it in 1979. The Ostini's are now into their third generation and continue to delight in serving their customers in the spirit and ambience of the 19th century hotel. (www.hitchingpost1.com)

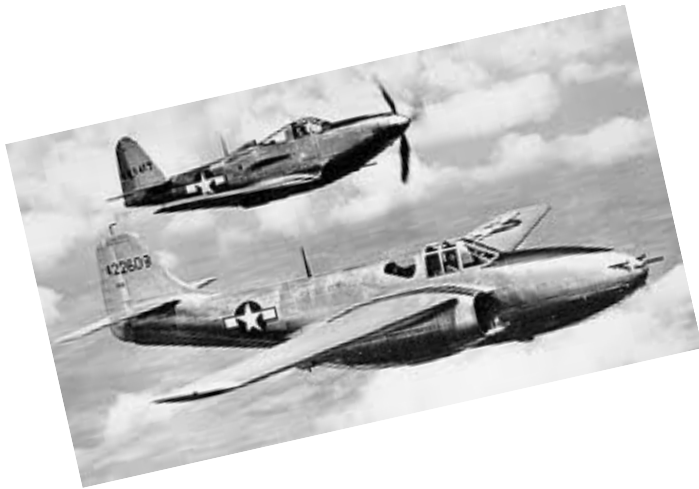

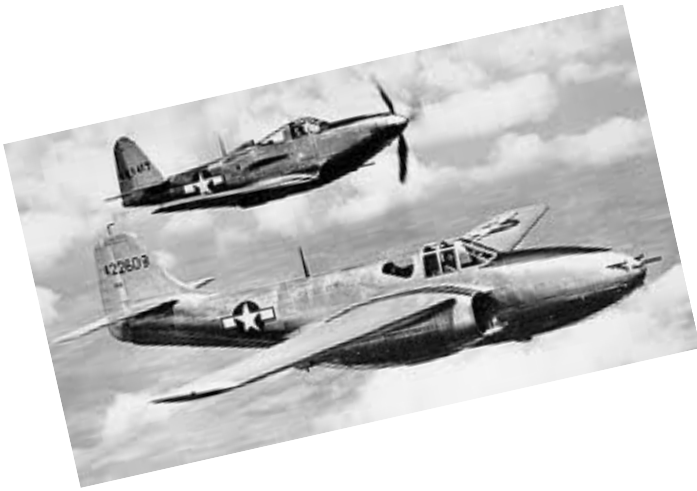
